# **Emergency Management**

Dave Beal gave an update on Speed signs, indicated once the Electric Utility is caught up on there projects, they will be installing the speed signs, Tornado siren has been ordered, Furnace for fire station has been ordered, and Windows 10 computers will be switched out to comply with windows 11 upgrade (2 of them).

# **OLD Business**

Jim Ronge indicated he has received complaints about semi traffic speeding on E Center St mainly between the hours of 4p-6p. and later at night. Chief Beal advised he will have his officers conduct more radar during this time frame.

Jim Ronge has concerns for the open basement at 328 and 330 S Fairfield the duplex that was torn down because of damage from a fire. The City ultimately tore the structure down as the 2 property owners didn't act to remedy, however the City allowed the basement to remain. Currently a plastic snow fence was installed around the open basement, by city crews. Jim Ronge was concerned about the liability the city has by allowing this to remain open all this time. Jim Ronge would like the Police Chief to follow-up with the Building Inspector to see what legal action can be taken to have this basement removed and filled in. Mayor Wegener indicated he would also have a conversation with out City Attorney concerning this matter as well.

#### **New Business**

Jim Ronge questioned about the Public Safety Building roof and how dirty it looks from the section of the high roof to the low roof. Chief Beal indicated he was aware of how it looks but hasn't had time to get up on the roof to try and clean it.
